

Only around 30% of hearing-impaired adults in the United States actually have hearing aids. The rest are deterred in large part by the hefty price tag: it's common for one hearing aid to cost several thousand dollars. The Georgia Hearing Aid Dispatch, in partnership with the **Georgia Public Service Commission**, removes the financial barrier to care for low-income Georgia residents and provides hearing aids at dramatically reduced costs.

In 2022, the Georgia Public Service
Commission unanimously awarded the
Georgia Charitable Care Network the

Program. The program, funded by the
Public Service Commission,
provides hearing aids to low-income
Georgia residents. GCCN coordinates
the care referrals between the patients,
audiologists and hearing aid
manufacturers, providing great
service to all.

## How do I apply?

Visit our website and click on the appropriate application (adult or pediatric). All applicants must provide:

- Proof of Georgia residency for at least 12 months
- Completed GCCN-approved Hearing Medical Recommendation
- Signed Medical Clearance or Medical Waiver
- Current (less than 6 months old) hearing test from a GCCN provider
- Completed application with ALL supporting documentation



### **How much does it cost?**

The hearing aid package is **not fre**e. Successful applicants will have a copayment, the amount of which will be determined by factors such as type and number of hearing aids. You will receive full details upon approval.

No adult applicant's monthly net household income may exceed 200% of the federal poverty guideline. All applicants must submit proof of income.

## May I reapply every year?

Individuals ages 20 years and older may apply once every three (3) years for services based on program funding.
